e know that improving our eating habits is vital to our heath, but the recent amendment to the reauthorization of the Child Nutrition Act sheds light that obesity among children and young adults have increased so dramatically. This states that this is a threaten to not only the overall health of America but the

future strength of our military. Under section 1065 in the findings and sense of congress on obesity and federal child nutrition programs, the (2) part states: "Twenty-seven percent, over 9,000,000, 17-24-year-olds in the United States are too fat to serve in the military." The full list of findings is the first article highlighted in our *Happenings of the Time* section.

Thankfully, over the past month, 221 Members of Congress – a Majority of the House – sent a letter to the Speaker supporting the President's request for an increase of \$1 billion a year for the Child Nutrition Programs and, now, 341 Members of Congress have voted to express their support for this same request. This is tremendous momentum for our cause and we should see a bill coming to the floor with this full funding sometime before July 4th! The article we highlight in this newsletter not only lists the amendment, but an article depicting the time line of the amendment and the final vote results.

The second article we highlight this month also has to do with an act of Congress, but this bill is still pending. Its the FDA Food Safety and Modernization Act, and this bill would amend the S. 510 Federal Food, Drug, and Cosmetic Act with respect to the safety of the food supply. Now that Congress has reached a conclusion on Wall Street reform, many lawmakers are calling for the passage of S. 510, citing recent food borne illness outbreaks to underscore the need for a revamped food safety system. This bill is somewhat controversial because it will require food handlers to keep better records and there will be tighter controls which always cost something, but it is common sense regulation to control against pathogens in the food supply.
